

# Recommendations for decision-making bodies and administration of State Higher Educational Institution "Kyiv National Economic University named after Vadym Hetman" and Higher Educational Institution of Ukoopspilka" **Poltava University of Economics and Trade "(Ukraine)** on advocacy of students based on the best practices of **European partners**

Commissioner for Student Rights - Ombudsman - is being implemented to represent and protect students' rights, freedoms and legitimate interests.

#### 2. Aim, functions and tasks of Ombudsman:

- 2.1. The Ombudsman is an official who oversees the observance of students' rights and freedoms, protects the rights, freedoms and legitimate interests of students within their powers on an on-going basis.
- 2.2. The Ombudsman performs the following functions: representative, advisory, preventive, informational and protective.

- 2.4. The Ombudsman has the following tasks:
- 2.3.1.be representative of students' interests in communication with University administration, local and state authorities:
- 2.3.2. analyze the process of implementation and ensure the rights and freedoms of students at the University;

- 2.3.3.to take precautionary measures to prevent violations of the rights, freedoms and legitimate interests of students;
- 2.3.4.to organize events in order to explain students their legal status, scope of their rights and responsibilities;
- 2.3.5.to take necessary measures in case of violation of students' rights, freedoms and lawful interests.
- 2.4. Ombudsman's activity is aimed to:
- 2.4.1. generalization, harmonization, formation and complete unimpeded realization of the rights, duties and freedoms of the University students in all spheres of life;
- 2.4.2. protection of all rights and freedoms of every student of the University;
- 2.4.3. prevention of violation of student's rights and freedoms and promotion of their restoration.

# 3. Principles of the Ombudsman's activity:

Humanism; legality; justice; objectivity; independence; democracy; accessibility; publicity; inviolability of privacy and confidentiality of personal information; professionalism.

### 4. Procedure of the Ombudsman's elections:

- 4.1. An ombudsman should be a citizen of Ukraine with high moral qualities, have enough experience in human rights activities, as well as in scientific and pedagogical activities.
- 4.2. An Ombudsman is elected by the highest collegiate student body by the majority of votes.
- 4.3. The Ombudsman is appointed to the post and dismissed from the position by the Academic Council of the University upon submission of the highest collegiate student body decision.
- 4.4. The Ombudsman is appointed for a five years term.
- 4.5. An Ombudsman should take an oath to University students while taking the office.

## 5. Ombudsman's authority:

- 5.1. The Ombudsman has *the right* to:
- 5.1.1. be receipted immediately by Chancellor, deans of faculties and directors of institutes, heads of structural and separate units;
- 5.1.2. attend meetings of the governing collegiate bodies of the University, student self-government bodies and public organizations of the University;
- 5.1.3 apply to the administration of the University, its structural subdivisions and local and state authorities regarding the provision of students' rights and freedoms.
- 5.2. Ombudsman is obliged to:
- 5.2.1. consider and provide reasoned explanations on the problem a student appeals;
- 5.2.2. resolve the problem impartially and objectively on the basis of current legislation;
- 5.2.3. keep confidentiality during problem solving process.
